### 4. Legislative report (Catie): - all info below updated on 4/4/23

 Here is the list of bills that we as NAPNAP California (our CA collaborative of all the NAPNAP chapters) are supporting for the 2023 Legislative Session:

BILL NUMBER + AUTHOR	SUMMARY
SB 625	an addendum to existing legislation recommending that when we do newborn screening/heel stick that it needs to come with a consent form that they can use the blood for research, store the sample, and no it can't be used for law enforcement/forensic evidence. would enable people to refuse for religious reasons and also be able to reach out afterwards to request for their sample to be destroyed
SB 509	school employee and people training for youth mental behavioral

	health - requires all districts to receive age appropriate mental health training
SB 551	This bill essentially amends 2 existing pieces of legislation to more directly support youth mental health services. First, it would amend the existing Mental Health Services Act by requiring participating counties to use a certain amount of funds to provide direct services on school campuses, essentially establishing direct services on school sites as a priority in terms of prevention and early intervention. It would also amend the existing Bronzan-McCorquodale Act (which governs the operation and financing of community mental health services) to require at least 20% of a mental health board's membership to be employed by a local educational agency, and at least 20% to be an individual who is 25 years of age or younger.
AB 303	This bill requires added language to an existing law, defining the requirements of the ATtorney General more specifically when they are to provide investigative assistance to local law enforcement agencies. The bill states that this assistance must include all investigative notes, reports, and related materials on individuals. Currently there is an online database known as the Prohibited Armed Persons File, which exists to cross reference persons who have ownership or possession of a firearm and fall within any class of people who are prohibited from owning or possessing the firearm. This would increase communication and collaboration with the attorney general and local law enforcement to ensure that this system is adequately used.  This hearing was on 2/28/23 and passed with all yes
SB2	This bill would increase training requirements particularly for those applying for concealed carry and restrict places where concealed carry license holders can possess the firearm, particularly referencing schools/parks, etc. It increases requirements of local licensing authorities when renewing or reinstating licensure. It would also prohibit a licensee from carrying a firearm to specified locations, including, among other places, a building designated for a court proceeding and a place of worship, as defined, with specific exceptions.

Requires manufacturers of baby food and formula to test for toxic heavy metals, list those on their websites. The bill would also require those manufacturers of infant formula or baby food products for which the FDA has adopted industry guidance for levels of a certain toxic heavy metal, include a label on the product that it has been tested for that toxic heavy metal and is within the FDA guidance.

## **AB 899**

- Catie will be stepping down in June, so let her know if you or someone you know would be interested. Can be labor intensive but super important.
- Meggie and Catie have been meeting with CANP to work on joint legislative and advocacy efforts, including Capitol Hill day and visits to offices of local and state legislators
- reminder that all are welcome to join NAPNAP's Child Health Policy Learning Collaborative (CHPLC) which meets at 5 PM PST via Zoom on the first Wednesday of the month, running from September through May. It is open to all NAPNAP members. Members discuss policy trends and advocacy solutions on national, state, and local levels. - AB 890 update: a reminder that ALL of us as NPs who have been in practice for a minimum of 3 years should complete the NP 103 application to practice without standardized procedures soon as possible. This application is free, quick, and available through the CA BRN website.
  - Some notes about requirements:
    - You have to have an attestation from supervising MD
    - you must have completed three full-time equivalent years of practice or 4,600 hours that were:
      - Completed after certification by BRN as an NP.
      - Completed within five years prior to the date of application for certification as a 103 NP.
      - o Completed in California.
      - Completed in direct patient care in the role of an NP in the category listed in 16 CCR Section 1481(a) in which the applicant seeks certification as a 103 NP. – note, pediatrics is one of these categories!
  - Important Notes: this may not have any impact on your day-to-day practice for quite some time. However, this is

the first step in obtaining the goal of full scope of independent practice for NPs in California so we really all should do it! If we all complete this application, this provides evidence as to the high level of our practice as nurse practitioners and the fact that we are CAPABLE of working without standardized procedures and without physician supervision. The more NPs that complete this application, the more that institutions and insurance companies will see that their NPs are qualified to work independently and then they will begin to make changes to their requirements for practice etc.

- Once you complete and are granted the 103 designation, be sure to present this to your institution. As mentioned, it may not impact your day-to-day yet but it's good for them to be aware.
- We encourage everyone to review this information about AB890, the NP 103 and 104 designations, and these processes. CANP has great information on this:
