## Legislative Update

Here are our latest updates!

### **State:**

- AB-890 (Nurse practitioners: scope of practice: practice without standardized procedures) has been passed! It was approved by the governor on 09/29/2020 and chaptered by the secretary of state on the same day, listed under Chapter 265, Statutes of 2020.
- The status of AB-2279 (Childhood lead poisoning prevention) is unchanged from the latest newsletter update in August 2020. It is still in process with the senate health committee process.
- The status of AB-2527 (School breakfast and morning snacks: non-school-aged children and guardians) is also unchanged from the latest newsletter update in August 2020 and still in process with the Assembly education committee

### **Federal:**

- Revisions to the APRN compact were adopted by the National Council of State Boards of Nursing (NCSBN) on August 12<sup>th</sup>, 2020. NAPNAP has opposed these revisions because they include a 2,080-hour practice hour requirement for all participating states and lack an APRN Advisory Board. As a reminder, if the APRN Compact is passed by 7 or more state legislatures, it will allow an advanced practice registered nurse to hold one multistate license with a privilege to practice in other compact states.
